Tim is a partner and advocate in the dispute resolution and litigation group. He also has significant experience in the fields of corporate insolvency and regulatory investigations. During his career Tim has appeared in matters before the English High Court, the Royal Court of Guernsey, and the Guernsey Court of Appeal.

Tim regularly acts for major corporates, investment and private banks, funds, private equity houses and other financial institutions, as well as for trustees, investment managers, investors, office holders, businesses and HNWIs. He has significant experience acting for the target (and occasionally the bidder) in complex schemes of arrangement, primarily in the takeover context. He often represents boards of directors, either in contentious or regulatory matters, derivative claims or unfair prejudice applications, and also as part of his board advisory practice, assisting boards of directors, or committees or constituents thereof, on commercially and financially sensitive or complex transactions and investigations.
